GSR.... In exercise of the power conferred by the proviso to article 309 of constitution and in supersession of the "Govt. Medical Store Depots (Pharmacist-Cum-Clerk) Recruitment Rules 1983* except as respects things done or omitted to be done before the supersession, the President hereby, makes the following rules regulating the method of Recruitment to the posts of Pharmacist cum Clerk in the Govt. Medical Store Depots(Mumbai, Chennai, Hyderabad, Karnal, Guwahati, Delhi& Kolkata) under Medical Store Organisation, Directorate General of Health Services, Ministry of Health& Family Welfare

- 1. Short Title and Commencement:-i) Theses Rules may be called the "Govt. Medical Store Depot Pharmacist Recruitment Rules 2017".
- They shall come into force from the date of the publication of the Rules in Official Gazette.
- 3. Number of Posts, Classifications and Scale of Pay:-The number of posts, its classification and scale of pay attached thereto shall be specified in columns 2 to 4 of the Schedule annexed to
- 4. Method of Recruitment, age limit and other qualification etc. :- The method of recruitment to the said post, age limit, qualification and other matters relating thereto shall be as specified in columns 5 to 13 of the said schedule.
- 5. Disqualification: No person:
 - a. Who has entered into or contracted a marriage with a person having spouse living; or
 - b. Who, having a spouse living, has entered into or contracted a marriage with any person, Shall be eligible for appointment to the said posts.
- 6. Power to relax: Where the Central Government is of the opinion that it is necessary or expedient to do so, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Saving: Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, or other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
