Important instructions:

❖ **Counseling will be held as per the Counseling Category Rank (UR/SC/ST/PH) only** and the seats will be allotted to the candidates as per the 2200 point Reservation Roster.

❖ All OBC candidates should report for counseling as per their **UR Category rank only**.

❖ SC/ST/PH candidates should report 2 **counseling days in advance** of their schedule date of counseling **but not before the date of commencing of counseling**. The candidates reported in advance may or may not get the seat allotted on the same day. If they do not get the seats allotted on the same day, they will be allotted the seats on the following day or dates or as mentioned in the schedule. Hence, they should make their own arrangements to stay for at least for 2-3 days in the counseling city.

❖ If SC, ST and PH candidates fail to report in advance, he/she will be marked absent and will not be considered for the counseling.

❖ Counseling will be strictly done at the venue opted by the candidate in his/her Application Form. **No change in the venue of the counseling will be allowed under any circumstance.**

❖ The candidates appearing for allotment by personal appearance should bring the following documents in original along with attested copies of the documents for verification failing which they shall not be allowed to participate in the allotment process:-

1. Admit Cards of Preliminary & Final Exam issued by CBSE.
2. Rank letter issued by CBSE.
3. Date of Birth Certificate (if 10th Certificate does not bear the same)
4. 10th Certificate
5. 12th Certificate **
6. 12th Mark Sheet
7. two passport size photographs same as pasted on the application form
8. The candidate should also bring the following certificate, if applicable:
 - (a) SC/ST Certificate issued by the competent authority.
 - (b) In case of OBC candidate, the category and the sub-category mentioned in the certificate should tally with the Central list of OBC.
 - (c) Disability Certificate issued from a duly constituted and competent Medical Board.

** Note: - Provisional certificate of 10+2 is permissible for those candidates who had passed in the year 2010 only.

❖ **Under any circumstances candidates without original certificates shall NOT be allowed to participate in the counseling.**

❖ **Candidates who have taken admission and deposited their original certificate with the Institute/Universities and come for counseling with a certificate stating that “their original certificates are deposited with the Institute/University”, will NOT be allowed to participate in counseling in any case.**

No authorized representative (only blood relative) is allowed to appear for counseling until and unless he/she should bring Medical certificate from the Govt. Hospital only of his/her hospitalizations/mis-happening, alongwith the original documents. Allotment letter will be given to the candidate when he/she is accompanied by his/her authorized representative who attended the counseling.
